
THE ANSWER

42,483 patients from the top ten medical cannabis states reported through RYAH Data between January 1 2018, and January 17 2020.

The states with the most patients have a variety of programs, some of which are not yet fully operational.

Patients overwhelmingly use the plant for five main concerns: anxiety, depression, stress, pain, and insomnia. There are small variations in the conditions treated between the top states.

There are big differences in strain preference. Californian patients tend to prefer high CBD strains, while Florida and Oklahoma lean towards strains with higher or more balanced THC ratios.



This report is based on information pulled from RYAH Data between January 1, 2018, and January 17, 2020


The State of the States 2018 Report by American Safe Access, uses an indepth ruberic for grading each state's medical cannabis access. [3]

The anlysis based on patient rights, civil protections, accessibility of medicine, ease of navigation, functionality, and consumer safety, determined seven states received top marks at B+.

These states included: California, Hawaii, Nevada, Illinois, Michigan, Ohio and Oregon. Of these, four are also on RYAH Data's list of top states by number of patients.






TOP AILMENTS TREATED


